

# COOKIE POLICY

Cookies consist of portions of code installed in the browser that assist the Owner in providing the service according to the purposes described. Some of the purposes for which the Cookies are installed may also require the User's consent. Technical Cookies and Cookies serving aggregated statistical purposes -

- Activity strictly necessary for the functioning of the service This Website uses Cookies to save the User's session and to carry out other activities that are strictly necessary for the operation of the same, for example in relation to the distribution of traffic.
